

NOTICE OF DISCONTINUANCE

Article 213 of the *Code of Civil Procedure*, CQLR, c. C-25.01

GENERAL INFORMATION

This form allows the plaintiff(s) to put an end to the proceedings brought against the defendants before the Human Rights Tribunal.

PROCEDURE

NOTIFICATION

You must notify your *Notice of Discontinuance* to all the parties to the proceedings.

The notification may be made, for example, by registered mail, courier service (Purolator, UPS, etc.) or by bailiff.

FILING AT THE COURT OFFICE

As specified in the [Directive of the Human Rights Tribunal](#), **two paper versions** of the *Notice of Discontinuance* must be filed, accompanied by proof of notification to the other parties, at the office of the Court of Québec in the district where the application is filed, and which is indicated on the procedures.

It must also be transmitted to the Tribunal using a technology-based medium. Additional copies may be requested by the Tribunal.

FILING WITH THE GREFFE NUMÉRIQUE JUDICIAIRE DU QUÉBEC

You may file your *Notice of Discontinuance* with the Greffe numérique judiciaire du Québec. To use this option, visit: <https://lexius-gnjq.justice.gouv.qc.ca/en/Accueil>

JUDICIAL FEES

There are **no** judicial fees to file your *Notice of Discontinuance*. However, the legal costs are borne by the plaintiff(s) who discontinue the proceedings, subject to an agreement between the parties or a decision of the Tribunal.

CHECKLIST
Before filing your <i>Notice of Discontinuance</i> :
☐ Each plaintiff must sign on page 1;
☐ You must enter your contact information on page 2;
☐ You must have two paper versions of the <i>Notice of Discontinuance</i> , accompanied by proof of notification to the other parties.

The form should only be printed on **one side of the page**.
