

NOTICE FOR RESUMPTION OF PROCEEDINGS

Section 84 of the *Charter of Human Rights and Freedoms*, CQLR, c. C-12
Section 35 of the *Regulation of the Human Rights Tribunal*, CQLR, c. C-12, r. 7

GENERAL INFORMATION

In accordance with section 35 of the *Regulation of the Human Rights Tribunal*, when the *Commission des droits de la personne et des droits de la jeunesse* (CDPDJ) decides to cease to act before the Tribunal in favour of a complainant or victim, the Tribunal convenes a case management conference to implement the measures necessary to ensure the proper administration of justice and to protect the rights of all the parties.

This *Notice for Resumption of Proceedings* allows a complainant or victim to resume proceedings before the Tribunal, after the CDPDJ has decided to cease to act in their favor. The complainant or victim then becomes the plaintiff.

The complainant or victim who intends to resume proceedings must notify the Tribunal and produce the *Notice for Resumption of Proceedings* within the time limit indicated by the Tribunal during the case management conference.

PROCEDURE

NOTIFICATION

You must notify your *Notice for Resumption of Proceedings* to all the parties to the proceedings within the time limit indicated by the Tribunal.

The notification may be made, for example, by registered mail, courier service (Purolator, UPS, etc.) or by bailiff.

FILING AT THE COURT OFFICE

As specified in the [Directive of the Human Rights Tribunal](#), **two paper versions** of the *Notice for Resumption of Proceedings* must be filed, accompanied by proof of notification to the other parties, at the office of the Court of Québec in the district where the application is filed, and which is indicated on the procedures.

It must also be transmitted to the Tribunal using a technology-based medium. Additional copies may be requested by the Tribunal.
